The purpose of the award is to recognize and support businesses that adopt and implement family friendly policies for their employees. Employees that have support at work to balance their family needs and work life help create a stronger New Mexico. The award recognizes family friendly policies in seven areas: paid leave, health support, work schedules, economic support, pay equity, diversity &

family friendly policies in categories one through four and have at least one policy in each category, five, six and seven.

SILVER (Rising Leader) Recipients meet any three family friendly

GOLD (Committed Leader) Recipients meet at least one family

▶ Platinum, Gold and Silver recipients receive the Family Friendly Business Award™ seal and a certificate of recognition that may be BRONZE (On the Pathway) Recipients that meet two or less family friendly policies receive information and educational materials to support them while on the pathway to becoming a more family friendly business/organization.

Award selection is based on the following family friendly policy categories:

Business policies ensure compliance with the Promoting Financial Independence for Victims of Domestic Abuse Act, Nursing Mothers' Rights at Work Act, and Fair Pay for Women Act (this compliance is a minimum requirement for qualifying for any Family Friendly Business Award™). nationalpartnership.org

► Applying for the award is easy and takes a short time to complete! There is no cost to apply or be recognized. Anyone with knowledge of your organization's HR policies can complete the application. Businesses renew their application each year for this award and let us know what family friendly policies have been added and updated.
